BAF members attended a civic event by United Bangalore on Lake Preservation & another event on SWD and STP issues in a 'Corporate Meet' – and interacted with policy makers and contributors. During June, BAF also filed the writ petition on retrospective STP for the 2nd batch of associations. There was also a hearing for the first batch of petitioners, which was adjourned with an order to serve notice to BWSSB.

The plight of Bellandur Lake was highlighted in an interesting way by holding a - 'Revive Bengaluru Marathon for Greener City' along the lakeside on June 5th 2017.

<u>CPCB</u> and <u>KSPCB</u> have given directions to <u>BWSSB</u> for technology upgradation of existing <u>STPs</u>. Perhaps this needs to extend to all <u>STPs</u> so that they actually function and efficiently so.

There appears to be further delay in notification of RERA rules in Karnataka, despite the Central Government notifying RERA with effect from April 30, 2016.

There have been a lot of queries on the applicability of GST for apartment associations. BAF is putting together a note on the same with the help of experts and will be releasing the same in the next few days.
