During the meet, <u>BAF Cluster Organization structure was unveiled.</u> Membership certificates and mementos were given out to all attendees representing their apartment or agencies. 2017-18 will be really treasured as a great year of achievement for BAF and its members — as it was a manifestation of the Power of Unity and in terms of results achieved. If we continue to work cohesively and represent our views in the manner done so far- it will only mean greater success for BAF.

Meanwhile during the month, <u>BAF has updated members on the GST exemption limit increase from Rs 5000 to Rs 7500 per month.</u> That comes surely as a big relief to our members affected. BAF GC thanks GST council minister for Karnataka, Hon Shri Krishna Byre Gowda for facilitating our representation to be heard. <u>BAF has also followed up with BWSSB and KSPCB for ensuring the relevant STP orders are passed, as well as penalty refund facilitation</u>.

BAF team has met the Chief Electoral Officer (CEO) of Karnataka and BBMP commissioner, apprised them of AARAMB and members' commitment, and ensured their support for smooth enrollment process - with clear escalation path for any problems / issues faced at local offices. BAF has also shared constituency/ ward level Revenue Officers (RO) & Booth Level Officers (BLO) details to facilitate smooth enrolments till elections for our member voting community. New members may approach their cluster leadership / BAF leadership for any support required. AARAMB initiative has thus been re-launched in January and we hope all member apartments are competing ferociously to ensure highest % of voter enrolments and the AWARDs of course! Install STPs, 99 Bengaluru flats told Jan 30, 2017
