
Dear Apartment Resident,

March 2021 also saw start of Covid Vaccinations Phase for senior citizens (we call them young hearts!). BBMP website provides all updates on those who wish to avail of this. Read more about this in the newsletter.

The following is the summary of key activities that BAF engaged in during the past few months & for many resolution awaited.

- 1. BAF represented in KERC hearing and presented objections to the **power** tariff hikes
- 2. On BBMP invitation, BAF and members participated in a BBMP war room meeting on "Effective Control Of Covid And Following Covid 19 Protocol At Apartments And Complexes This meeting was chaired by BBMP Commissioner Mr. Manjunath Prasad & IAS special commissioner for Health & IT Mr Rajendra Cholan. It addressed concerns & precautions on the new Covid community outbreaks and need to curb super spreader events.
- 3. Beyond Carlton memorial event (11th year of the Carlton Fire tragedy), also saw BAF member sharing a panel discussion on need for fire safety, as also what builder & RWAs need to comply with, to ensure Fire safety in apartments.
- 4. BAF GC attended an event held in Bangalore presided by the Union Finance minister Ms Nirmala Sitharaman and submitted relevant inputs to Union Finance Budget inputs, that would benefit apartments. Representation emphasized elimination of GST & Income Tax, incentivize green initiatives, subsidies to "green" infra and equipment deployed, waiver on property taxes for "Atmanirbhar apartments etc.
- 5. A BAF team met with BESCOM MD to resolve issues on SRTPV, Transformer maintenance, Power disconnections, EV charging Stations etc. A notice on Transformer maintenance along with divisional contacts has been released.
- 6. BAF team has impleaded in the DoD-PIL (KAOA) matter that seeks to make DoD associations null & void. During hearing in February, many other parties have also impleaded. BAF legal & finance team has been formed to focus on these efforts and ensure that legality and functioning of any associations formed by Apartment Owners is covered adequately under provisions of law and is fair and just for all owners. Details will be updated as and when more inputs are available.
- 7. BAF team also met Chief Secretary, GoK and appraised him of various issues w.r.t. STP/NGT impact on apartments, KAOA, SRTPV net metering and other concurrent issues. The Chief Secretary has assured of interactions to resolve many of these issues faced by BAF member apartments.
- 8. Another BAF team met with Chief Election Officer on various clarifications on voter ID card application, rejection reasons & issuance of cards and issues of online process. These are being looked into and assured of support to BAF members.
- 9. A BAF team also met with KSPCB on various STP notices and power disconnections to apartments. A new STP notification superceding all previous notices has been released & BAF will soon hold a BAF-Ki-BAAT session for the same.
- 10. BAF tied up with World Wildlife Fund (WWF) to roll out Plastic Reduce (Tide Turner), Earth Hour and Adopt a Tree challenges. BAF urges all its members and every apartment resident to participate in this initiative

4 vendors chosen to set up sewage sensors *Feb 09, 2021*

The Karnataka State Pollution Control Board (KSPCB) has short -listed four vendors who will install sensors for online monitoring of sewage treatment plants (STPs) in large apartment complexes and commercial establishments mainly shopping malls. Only plants with capacity to treat 500 KLD of sewage are initially expected to get sensors, estimated to cost a minimum of Rs 4 lakh. It's learnt that only around 100 buildings in the city have such big plants. No apartment complex has come forward so far.

The efforts of the city police to reach out to citizens during the COVID-19 pandemic has helped gain their trust, according to a survey taken up by the Janaagraha Centre for Citizenship and Democracy, and the German research foundation Hanns Seidel Stiftung. Of the citizens surveyed, 90% felt a little or a lot more positive now about the police in Bengaluru than before the pandemic.

BBMP finds a way out of Covid-19 vaccine hesitancy

Feb 26, 2021

Apartment associations, with their ready database of senior citizens and persons with comorbidities, could be an ideal starting point to address vaccine hesitancy and boost the vaccination drive among the general public, reckon healthcare specialists. Once the most vulnerable sections are identified, convinced about the benefits and vaccinated, the other family members would be more open to take the vaccine, the specialists feel. "The government and the BBMP should be proactive in collaborating with the apartment associations to take this forward," says a doctor. Nearly a thousand volunteers signed up with BAF to collect baseline data, so a tie-up amid Palike and BAF may be decisive in driving the vaccination process.

Sensors for STPs now must only for large apartments in Bengaluru

Feb 08, 2021

A public notification issued by the Karnataka State Pollution Control Board (KSPCB) clarified that the sensors are mandatory at present only for mega commercial or residential apartments that treat 5 lakh litres or more of sewage per day.

The Pollution control board is working on an app to collect grey water from apartments to water parks and gardens. An Uber-like tech solution is being currently designed by the Karnataka State Pollution Control Board (KSPCB) to address a common but major complaint of apartment dwellers, who are not allowed to discharge excess treated water into BWSSB's underground drain network (UGD) or BBMP's storm water drains so far.

Directions To All Authorities To Stop Manual Scavenging: Karnataka High Court Directs State Govt

The Karnataka High Court on Wednesday suggested to the State government to consider issuing a general direction to all authorities and agencies and instrumentalities of the state for implementation of Rule 3 of the said Rules of 2013. The State government shall also consider issuing a direction that whenever authorities appoint contractors, condition of complying with Rule 3, should be incorporated in the contract for work order."

If they failed to do so, the buildings would be demolished and the demolition cost borne by the owners.













Dangling Electric, TV cables common to all cities in India; take action: Karnataka High Court

Feb 24, 2021

Over 400 deaths have occurred in Bengaluru city due to electrocution in the last few years. The Karnataka High Court directed Karnataka government authorities and Bruhat Bengaluru Mahanagara Palike (BBMP) to take action against private internet, television and cable operators responsible for such hanging cables in Bengaluru.

Pollution board issues STP norms Mar 03, 2021

The Karnataka State Pollution Control Board (KSPCB) has released guidelines for the design and location of sewage treatment plants (STPs). BBMP asked by HC to give a plan for removal of potholes

Mar 03, 2021

A survey was conducted by Karnataka State Legal Services Authority (KSLSA) on the status of roads on the direction of the High Court. A whopping 5,435 instances of potholes, bad stretches of roads and footpaths have been reported by citizens through WhatsApp chatbot to the KSLSA. The report pointed out that of the 5,435 responses from citizens, 437 were related to potholes and bad road issues, and the remaining 4,998 are related to footpaths.

The State Cabinet has decided to establish a separate entity, the Bengaluru Solid Waste Management Company to help Bruhat Bengaluru Mahanagara Palike (BBMP) manage the city's growing solid waste. It will be responsible for collecting, transporting, and processing waste to produce energy. While the BBMP will invest 51% in the newly formed organisation, the State government will contribute the remaining.

The court also directed the BMRCL, Bangalore Electricity Supply Company Ltd and the City Police to look into the allegation of encroachment of footpaths made in the petition..

Residents beautify the 250 ft long road

Rustam Bagh is a quaint enclave of about 700 families, tucked cosily behind Manipal Hospital on Old Airport Road. It's a quiet, serene locality but with a single, very narrow pathway leading into and out of the community. This narrow road is abutted by the Manipal Hospital wall on the one side and the Seventh Adventist School wall on the other. This thin sliver of road has been widely used by vendors, taxi & auto rickshaw drivers and general oafs as a public toilet and a garbage dumping ground. It has been quite an eyesore for quite a while, not to mention an unhygienic, foul-smelling stretch of asphalt. Numerous appeals to health and civic officials bore little fruit and only added to our frustration and disgust.



Finally, the residents decided that self-help is the best help and they have to take it upon themselves to keep the locality and community clean and hygienic. The project was simple: beautify the place. The word was spread in the community seeking volunteers to help with the project. Dozens of eager residents willing to participate were enlisted.

First, the wall was cleaned and painted with a white primer to remove the grime and the muck. Simultaneously, all the junk and garbage was cleared.

.. Initiatives & Impact

The Rustam Bagh Flora & Fauna team, then planted saplings and placed potted plants all along the wall.

Finally, the wall-painting project was opened up to the entire community. A professional artist helped draw the pre-planned designs with messages related to citizens' civic duties. Printed sheets of the designs and colour schemes were passed to the passionate volunteers, aged from 6 years old children to 75 years old senior citizens.

By sundown, the entire wall was almost finished. One of the patches on the wall will pay tribute to all those who gave up their precious time to help with the project: it will have all their palm prints emblazoned on it.

From a gloomy, ugly, smelly spot, the place had been transformed into a bright, clean, jubilant site in just a few hours. The school wall looks so lovely now that Manipal Hospital has agreed to let the volunteers paint their wall, too!



The project required the necessary permissions from the school management, the Bengaluru police, and the BBMP.


