ADVISORY to RWAs regarding Home Quarantine enforcement

In exercise of powers conferred under Section 24 of the Disaster Management Act, 2005 to Commissioner, BBMP through Order No: RD158TNR 2020 dated 14-04-2020 of Government of Karnataka and in accordance with the Advisories issued by the undersigned to the Resident Welfare Associations in the context of Unlock 1.0 on 09-06-2020, the following information is issued for the Resident Welfare Associations and all the residents in the jurisdiction of BBMP, Bengaluru Urban and Bengaluru Rural districts.

It shall be noted that the RWAs' of BBMP have done a commendable job thus far by following the SOPs issued by the undersigned.

The Government of Karnataka has taken various measures to prevent the spread of COVID-19 Pandemic in the state, which includes effective tracing and quarantining of the COVID-19 positive persons and their contacts.

As the incidence of the COVID-19 Positive Cases is increasing in BBMP, it is important to ensure that Home Quarantine rules are strictly monitored by the Resident Welfare Associations as per the SOP dated 06-06-2020 issued from Bruhat Bengaluru Mahanagara Palike.

A task force has been formed by the order of the Chief Secretary, Government of Karnataka to monitor the Home Quarantine (HQ) operations vide Order No. RD 158 TNR 2020 dated 15-06-2020 to ensure that HQ is enforced strictly in the jurisdiction of BBMP, Bengaluru Urban, and Bengaluru Rural districts.

The successful enforcement of the Home Quarantine depends on the active support and participation of the citizens and the society. In this regard, the Resident Welfare Associations (RWAs) are hereby advised to note and effect the implementation of the following activities:

- 1) To be watchful and keep an unobtrusive lookout for any visitors or members of the house who returned after traveling outside the state and report to the BBMP helpline or Police Control Room or through WhatsApp/Telegram message at +91 9777777684.
- 2) To advise the household on HQ about the HQ procedures and also paste a poster outside the house, that the household members are on HQ for 14 days.
- 3) To assist the household in effectively conducting their HQ.

- 4) To ensure there is no social stigma attached to the persons under HQ and appreciate that effective HQ is key to prevent the spread of the pandemic.

It is also advised to take due care not to violate any legal rights of the members or commit anything unlawful. In case of any doubt or requirement of assistance, both the RWA Office bearers or the members can seek help through State or BBMP helpline.

This advisory is issued seeking your co-operation and support to stop the spread of COVID-19 pandemic in BBMP, Bengaluru Urban, and Bengaluru Rural Districts.

Let us fight COVID-19 pandemic together.
