Delivery on every alternate day for each apartment.

Order cut off time for delivery on a given day is 10 am of previous day

Payment options and conditions are specified in order form

Apartment Association would need to coordinate this, though individual households can place order

Order for an apartment will be delivered collectively which then weighed, billed and distributed by supplier with the help of Association
